Under the visionary leadership of Executive Director Geri Wright and Kasser Family Artistic Director Matt August, ATC brings world-class artists together to create exceptional theatrical experiences for Tucson and the Tempe/Phoenix metro area.

Beyond the stage, ATC enriches lives through outreach, education, and community engagement, reaching over 300,000 annually. From mainstage productions to student matinees and the National Latine Playwrights Award and Festival, we believe in the transformative power of theatre to inspire and connect.

Arizona Theatre Company provides professional theatre arts programming to students across Arizona through our student matinee program. During the 2023-24 season, this initiative enriched the lives of more than 3,500 students.

We offer \$1 tickets to Title I schools and discounted tickets to all other student groups, ensuring that financial barriers do not prevent young audiences from experiencing professional theatre. Following each performance, students engage in dynamic panel discussions with the artistic team and actors, deepening their understanding of the production. To further enhance the

The Theatre's endowments were established to support, further and enhance the mission of the Theatre. Endowment assets include those assets of donor-restricted funds that the Theatre must hold in perpetuity or for a donor-specified period. As required by U.S. GAAP, net assets associated with endowments funds are classified and reported based on the existence or absence of donor-imposed restrictions.

**Part X, Line 2:**

The Theatre is exempt from income taxes under both federal (Internal Revenue Code Section 501(c)(3)) and Arizona income tax laws. The Theatre is classified as other than a private foundation under section 509(a)(2).

Accordingly, no provision for federal or state income taxes is recorded in the accompanying financial statements. Income from certain activities not directly related to the Theatre's tax-exempt purpose, however, may be subject to taxation as unrelated business income. Management is not aware of any matters which would cause the Theatre to lose its tax-exempt status.

Management has considered its tax positions in accordance with the accounting standard for uncertainty in income taxes and believes that all of the positions taken in its federal and state exempt organization tax returns are more likely than not to be sustained upon examination. The Theatre's returns are subject to examination by federal and state taxing authorities, generally for three and four years, respectively, after they are filed.

The Theatre recognizes interest and penalties related to unrecognized tax benefits in administrative and general expenses and accrued expenses in the accompanying financial statements. There were no recognizable interest and penalties during the year ended June 30, 2024 and 2023.
