The Theatre's endowments were established to support, further and enhance the mission of the Theatre. Endowment assets include those assets of donor-restricted funds that the Theatre must hold in perpetuity or for a donor-specified period. As required by U.S. GAAP, net assets associated with endowments funds are classified and reported based on the existence or absence of donor-imposed restrictions.

**Part X, Line 2:**

The Theatre is exempt from income taxes under both federal (Internal Revenue Code Section 501(c)(3)) and Arizona income tax laws. The Theatre is classified as other than a private foundation under section 509(a)(2). Accordingly, no provision for federal or state income taxes is recorded in the accompanying financial statements. Income from certain activities not directly related to the Theatre's tax-exempt purpose, however, may be subject to taxation as unrelated business income. Management is not aware of any matters which would cause the Theatre to lose its tax-exempt status.

Management has considered its tax positions in accordance with the accounting standard for uncertainty in income taxes and believes that all of the positions taken in its federal and state exempt organization tax returns are more likely than not to be sustained upon examination. The Theatre's returns are subject to examination by federal and state taxing authorities, generally for three and four years, respectively, after they
